SUMMARY

The purpose of this report is to provide an update on the scope and indicative costings relating to the proposed Karlgarin Bowling Club Building. The draft concept plans and associated costings are attached for information.

BACKGROUND

The Karlgarin Bowling Club was established in 1973 at which time it comprised a grass green rink and the associated club room on the northern end of the rink as there today. The club room is essentially a shed with a small enclosed office on the western end and an enclosed tea room on its eastern end. The building contains asbestos. A synthetic turf surface was installed in 2010 which was then replaced in 2015 following storm damage. The rink was constructed over three (3) lots being 19, 20 and 21, with the middle Lot 20 being a Crown Lot vested in the Shire for Bowling Green and the two lots either side freehold Lots owned by the Karlgarin Country Club. The Karlgarin Bowling Club and the Karlgarin Country Club (est. 1953) have been intrinsically linked since the construction of the bowling rink. The Karlgarin Country Club Liquor Licence extends across from the Karlgarin Country Club building to the Karlgarin Bowling Club. Generally speaking, when there is a bowling event held the Country Club is open, however in recent years with reduced operating hours of the Country Club this is not always the case. The Bowling Club Building has served its purpose to date, however less so in recent years with the reduced operating hours of the Country Club and greater expectations to meet with modern standards.

In 2021 the Shire of Kondinin undertook a review of its Sport and Recreation Facilities Plan. During the preparation of this document, the Karlgarin community identified the need to build a new bowling club to replace the existing building to provide a functional space that meets with modern standards. The Karlgarin Bowling Club Building is included in the updated Sports and Recreation Facilities Plan 2021 – 2031 endorsed by the Council on the 16th of June 2021 and the amended version endorsed on the 16th of March 2022. The Plan proposed works to be undertaken at the Kondinin Bowling Club in the (medium term) (i.e. 3 to 5 years from 2021).

Following the inclusion of the new Bowling Club Building in the Sports and Recreation Plan 2021 – 2031, representatives of the Karlgarin Bowling Club engaged the services of a modular building company to prepare draft plans and associated costings for the project. The estimated cost of the development is \$500,000 for the proposed modular concept building as shown in the attachment. Consistent with the Shire's Policy FACS 003 which notes "All requests to improve existing facilities or construction of new facilities will be considered by Council on a 1/3 Council, 1/3 Organisations and 1/3 Government Grant Basis. All projects to be discussed fully by the appropriate Council Committee with the Organisation Committee before the application is submitted to Council for consideration', the Karlgarin Bowling Club have followed due process and discussed the matter with their local community and committed up to \$150,000 via contribution from the Karlgarin Progress Association and \$80,000 from the Karlgarin Bowling Club towards the project.

In the initial concept planning for the project, some issues have been identified including the disability toilet at the Public Toilets behind the Karlgarin Hall not meeting with current disability requirements. Significant works to upgrade to modern requirements maybe difficult to achieve and would be challenging and cost prohibitive to build a ramp to the existing toilets if they were to be upgraded, meaning that the new build would require a disability toilet. Notwithstanding this, it is likely that the existing toilets can be factored in for general public access reducing the requirement for standard toilets in the new build.

Other matters of constraint that have been identified include a water main that runs along the length of the rear laneway that cannot be moved or built over. Significant site works have also been identified that would be required if the proposed new building is positioned at the existing location of the Bowling Club. For instance, to create the levels required the retaining wall would need to be extended to the north which would encroach onto the water main. These constraints will need to be factored into determining the best location to install the modular building.

The matter of land tenure has also been discussed over the years, in which Council at its Ordinary Meeting on the 20th of October 2021 approved the offer from the Karlgarin Country Club to purchase the Lots 19 & 21 Federal Street, Karlgarin. Settlement took effect on the 23rd July 2023. A Crown Inquiry Form was submitted to the Department of Planning, Lands and Heritage to amalgamate the newly acquired lots to the middle Lot 20 to create one reserve for bowling green. To date, a case file has been provided, referrals have been undertaken and the matter is progressing through the Department of Planning, Lands and Heritage.

A meeting has been scheduled with a representative from the Department of Local Government, Sport and Cultural Industries on the 19th December 2023 to discuss the suitability of the project for funding through the Community Sports and Recreation Facilities Fund (CSRFF). Projects for the small grant round for projects under \$500,000 are held twice yearly closing in March and September and the forward grant round for over \$500,000 once yearly closing in September.

SUMMARY

To provide an update on the current and projected requirements in the management of the Shire's Sporting Venues.

BACKGROUND

As outlined in the Integrated Planning and Reporting Framework Guidelines, the effective management of assets is crucial to the sustainable delivery of local government services. The Shire's assets need to serve the needs of the community, in alignment with the Strategic Community Plan and the Corporate Business Plan and integrated with the Long-Term Financial Plan. As local governments hold a large portfolio of long-lived assets, it is critical to plan and prioritise the maintenance, renewal and replacement of existing assets and the acquisition of new assets, requiring a long-term "whole of life" view of asset management.

The Shire's Asset Management Plan was adopted by Council at its April 2023 Ordinary Meeting providing overarching guidance to implement strategy including financial capacity (integrated with the Long-Term Financial Plan and the Corporate Business Plan) in respect of providing and maintaining adequate assets for the Shire of Kondinin. With a number of new builds and renewal projects that have been outlined in the Shire's Integrated Planning Framework documents, robust asset planning and costings are paramount to develop an understanding of the long-term costs of the existing asset base to inform budget decisions.

Sound management of assets is an important and integral part of senior management's responsibilities. Part of this responsibility is achieving high quality in the construction, renewal and maintenance of a local government's assets. This assists in achieving high value for money spent, extending the life of important assets and minimizes maintenance and replacement costs.

The Shire aims to work with the local community to ensure that the Shire's assets are commensurate with the needs of the community whilst also being within realistic budget parameters, meeting compliancy and minimizing maintenance and replacement costs.

As a way to engage with the community on the Shire's sports facility assets, community workshops were held in 2021 as a precursor to the preparation and adoption of the Shire's Sport and Recreation Facilities Plan 2021 - 2031. Below is an extract from the document with the list of projects that were identified in the plan to be completed in the short term (1 - 2 years), medium term (3 - 5 years) and long term (5 years plus).

A status report has been provided for each project in **blue font** under each item. To date the majority of items have been completed or are in progress consistent with the timelines prescribed in the plan. The main exception is the upgrades to the Hyden Recreation Building of which has been put on hold until such time as a confirmed scope and community financial contribution was determined to progress the matter.
