# Summary

The purpose of this report is for Council to approve the easement and associated plan attached via common seal by order of council.

# **Background**

Over 10 years ago a pedestrian pathway was constructed inside the southern lot boundary of Lot 802 Hyden-Lake King Road, Hyden to create a continuous pathway from the Hyden Town Centre to Wave Rock. With the recent construction of a new vehicular access way into Lot 802 Hyden-Lake King Road, it has become apparent, there is no formal agreement between the land owner and the Shire of Kondinin enabling public access to utilize the pathway.

A meeting was held on site on the 5<sup>th</sup> December 2024 with the land owner and the Shire's Administration to discuss the easement and the recommended width appropriate. Acknowledging that the existing fence line does not represent the lot boundary, it was agreed that a two (2) metre set back from the northern side of the existing sealed pathway would be appropriate, resulting in a total ten (10) metre width easement from the southern lot boundary.

The matter was then presented to the Ordinary Meeting of Council held on the 18<sup>th</sup> December 2025, in which Council resolved as follows:

- 1. **SUPPORTS** the engagement of suitably qualified practitioners to prepare an easement to formalize public access to the existing pedestrian pathway through freehold Lot 802 on DP 76835 Hyden-Lake King Road, as per the plans attached;
- 2. **SUPPORTS** the Shire of Kondinin as beneficiaries and fully responsible for the management and maintenance of the proposed easement on Lot 802 on DP76835 Hyden-Lake King Road, Hyden;
- 3. **AUTHORISES** the Chief Executive Officer to follow the provisions pursuant to section 195 & 196 of the Land Administration Act 1997 to complete the process; and
- 4. **APPROVES** all costings associated with the preparation of the easement be borne by the Shire of Kondinin

#### Summary

The purpose of this report is to seek approval from Council to commence the process to amend the purpose of Crown Reserves 28832 and 28833 to include 'parking' to enable the preparation of a Local Law relating to Parking to apply to the Wave Rock Precinct.

## **Background**

Under the Shire's current governance framework, the Shire of Kondinin is unable to issue parking infringement notices in the Wave Rock Precinct, meaning formal parking infringements cannot be issued and money cannot be recouped from motorists not displaying a parking ticket in the Wave Rock Precinct. Under current arrangements, the Shire is limited to issuing a warning notice of unpaid entry fees.

In order to enable formal infringements to be enforced, the Shire's Administration are investigating the possibility to develop a dedicated Local Law relating to Parking.

The proposed areas in which the Local Law relating to Parking would apply include Crown Reserve 28832 and Crown Reserve 28833 which are currently designated the purpose of 'Caravan Park' and 'Recreation and Wildlife Park' respectively.

In order to progress with the preparation of this Local Law, the Department of Planning, Lands and Heritage have recommended that the Shire seek approval to amend the purpose of the two Reserves to include the additional purpose of Parking.

In light of the above, it is recommended that Council support the Officer's Recommendation.

# **Background**

The Hyden Progress Association approached the Shire of Kondinin to utilize the disused sleepers and railway tracks within the Hyden Railway Reserve for their historical displays being installed on Lot 45 on DP 5691 Marshall Street, Hyden (within PTA Lease 3553).

On receipt of this request, the Shire's Administration contacted the Public Transport Authority (PTA) and Arc Infrastructure Pty Ltd via the lease managers of the subject land to formalise permission for this request. Approval has since been received via the Deed of Gift attached. On signing of this Deed, the lease managers will then send through a new 10-year PTA Lease 3553 for a portion of Lot 45 on DP 5691 Marshall Street, Hyden, with a designated use 'Community Purpose' which will include on-going beautification of the site and inclusion of train carriage and engine.

The PTA have also formally approved in writing the painting of the goods shed located on Lease 3553 in a neutral colour.

The Department of Communities is making up to \$50 million in grant funding available under the Call for Submissions process to help increase the supply and diversity of new and refurbished social housing in regional Western Australia.

The process is open to Local Governments and Community Housing Providers registered under the WA Community Housing Regulatory Framework. With neither the Hyden Lions Club or the West Court Retirement Village registered housing providers, the Shire of Kondinin as the local government will need to be applicant.

## Summary

This report is to provide information and updates in relation to the Discovery Centre Project (the 'Project') and responses to the Business Plan.

## Background

Since 2018, the Shire of Kondinin has been working with the Hyden CRC (HCRC) and the Hyden Progress Association (HPA) for construction of a Centre in Hyden for the CRC and to promote tourism for the Shire and region.

An application was made for funding in 2020 but failed to gain financial support. The Working Group has been following through with improving the project and seeking funding.

This Project is in the Shire of Kondinin Strategic Community Plan and Long-Term Financial Plan.

Funding through the Federal Growing Regions Funding will be available now and will be the final round of funding for this project. It is likely that other funding may be available but details and timeframes are not known and no indications of future funding have been made.

The Working Group are also trying to get funding from State Government to reduce the financial impact of the project for the Shire of Kondinin residents and ratepayers.

Funding is currently being sought through the Regional Precincts and Partnership Program (RPPP).

#### Comment

At the recent meeting of the Working Group, it was discussed about the possibility of lodging an application for the full amount through the Regional Precincts and Partnership Program. A previous application had been approved based on concept drawings similar to ours. Staff are currently working on the application process. This led to the motion from the working group.

There is still a possibility that with the election, that funding may be altered and applications dismissed for future funding with some alterations.

During the working group session, the Chair, Mr Brian Mayfield raised about his position and did the working group want to hold elections. It was felt that as we are still seeking funding through political means, the chair should remain with Mr Mayfield as his assistance with political connections would be valuable.

As previously mentioned, Wheatbelt Development Commission are interested in assisting with the production of a glossy booklet for our project to assist in trying to raise grant funding. As the current quote for the building is due to expire on 30<sup>th</sup> June, we will be seeking an update to this quote, plus and update to the economic benefits forecast to ensure information matches and is still relevant for the production of the booklet. # **Background**

Section 5.37 of the Local Government Act 1995 (the Act)

## 5.37. Senior employees

- (1) A local government may designate employees or persons belonging to a class of employee to be senior employees.
- (2) The CEO is to inform the council of each proposal to employ or dismiss a senior employee, other than a senior employee referred to in section 5.39(1a), and the council may accept or reject the CEO's recommendation but if the council rejects a recommendation, it is to inform the CEO of the reasons for it doing so.
- (3) Unless subsection (4A) applies, if the position of a senior employee of a local government becomes vacant, it is to be advertised by the local government in the manner prescribed, and the advertisement is to contain such information with respect to the position as is prescribed.
- (4A) Subsection (3) does not require a position to be advertised if it is proposed that the position be filled by a person in a prescribed class.
- (4) For the avoidance of doubt, subsection (3) does not impose a requirement to advertise a position where a contract referred to in section 5.39 is renewed.

# Section 5.39, 1(a)

- (1a) Despite subsection (1)
  - (a) an employee may act in the position of a CEO or a senior employee for a term not exceeding one year without a written contract for the position in which the employee is acting; and
  - (b) a person may be employed by a local government as a senior employee for a term not exceeding 3 months, during any 2-year period, without a written contract.

Loosely based, this listed staff as per Section 5.37 as it did require the employment of Senior Officers to have consultation with Council.

This Policy was removed with the changes to the Policy Manual in January 2021 by the recommendations of the CEO at the time.

#### Comment

Section 5.37 has been debated by Councils for several reasons, it does give Council some control of the employment of Senior Staff, but was also seen as Council getting into the administrative functions of the Shire which should be for the CEO.

As part of the discussion in the current round of Local Government Reforms, it was mentioned about the possibility of removing Section 5.37 of the Act, however it was requested to remain.

As per the Act, any staff member appointed or dismissed as a Senior Employee, Council is to be informed and can accept or reject the CEO's recommendation. If the recommendation is rejected, a reason must be given to the CEO.

The are several concerns with listing staff under section 5.37 of the Act. These include:

- additional steps are required to engage staff for these positions. The appointment
  of staff into these roles must be ratified by Council before the position can be
  official.
- If staff are dismissed, it must be ratified by Council before finalized. This also offers the staff some protection.
- Staff may see it as a deterrent in that they are also employed by the Council, therefore they have multiple bosses instead of just the CEO.
- Staff can attempt to develop relationships with members for protection of their position.
- Staff may be intimidated by Members as a controller of their position.
- It can be seen as Council being involved in an administrative function.
- It can be seen as Council trying to assert authority and override the CEO.
- Council need to ensure they are following employment legislation when deciding against the CEO.

There are also several benefits that can be gained with the listing in place:

 CEO's must get Council approval to employ or dismiss staff, giving Council some control in the process.

It should be noted that current Executive Staff are already under contract for their employment and as such, this change in policy would impact their positions until the renewal of their contracts as this would be a significant change to their current employment conditions.

In discussion with Senior Staff about the change and the implementation of a Policy, concern was raised by all the senior staff for the following:

- why it was needed?
- It was seen as an attack on staff and the jobs that they do.
- If Council is wanting to control their positions, what have they done wrong for this?

As seen by the reaction of staff, this change to Policy can cause concern for staff. The general concern is why Council feels is needs to change the current arrangements, have staff done something wrong?

Staff have been advised that this policy would only apply from contract renewal.

To consider the Celebration of 100 years of Local government for the Kondinin Road Board and Shire of Kondinin with a special event.

# **Background**

The Kondinin Road District was gazetted on 15 May 1925, separating the district from the Roe Road District with effect from 1 July in that year. The first election was held on 5 September 1925, with the first meeting taking place seven days later (Wikipedia).

In 1961, The Kondinin Road Board became the Shire of Kondinin with the changes to the Local Government Act 1960 and has continue to current day.

# Comment

For the date of the event, staff initially looked at the 18<sup>th</sup> of May being the closest weekend to the Gazettal date, but as the Kondinin Road Board did not start until 1<sup>st</sup> July 1925, it would be more appropriate to celebrate the Centenary around this date. The 1<sup>st</sup> July is a Tuesday, with the nearest weekend being 29<sup>th</sup> June or 6<sup>th</sup> July (Sunday).

In discussion with the Shire President, it was felt that to make this event a large event and a full day could be difficult to ensure we can cover the full area and the 3 towns of the Shire. Given that it would clash with sports, it would also make it difficult to fit in with the movements of the local residents as support of the sports would likely be a priority.

It was therefore considered that a smaller event to mark the occasion would be more appropriate, with the event being held midday to allow former Presidents and Council Members to attend from other areas and return in the same day.

For promotional items for the event, it was considered for the following:

250 Kondinin Road Board / Shire of Kondinin mugs

250 Kondinin Road Board / Shire of Kondinin glasses

1000 Kondinin Road Board / Shire of Kondinin pens.

# **Summary**

To consider the allocation of \$20,000 from the Shire IT Reserve account to allow for the upgrade of the Office Software and Main Server.

# **Background**

The Shire of Kondinin currently uses Microsoft Office for most of the normal administration actions of documents (Word) spreadsheet (Excel) and Notices (Publisher). The current version in use of Microsoft Office 2019, which is quickly becoming obsolete and will no longer be supported by Microsoft. This was the last Office Software system that had a single license purchase per copy required.

The Shire of Kondinin Main Server is also aging and the current software for the service will again, not be supported by Microsoft. As the Server is the holder of the Shires main data, it is critical to ensure the server is maintained and able to meet the demands of the Shire. At this time, the Server needs upgrades as more space is required for data services for the Shire. The Server currently only has 16.3Gb of free data space. The changes to the software will allow more data to be cloud based.

#### Comment

The change on software from Office 2019 to Office 365 will enable staff access to updated software and also use other items such as Teams (with an account) and also One Note. Access to Office 365 will also give access to One Drive and allow staff to transfer large folders of information by allowing access rather than trying to reduce the size of the documents.

The change in software will as change the operational costs as Office 365 comes with an annual license fee whereas the old version of Office had a once off license fee. This annual fee will need to be considered as part of the operational charges for the Shire.

The changes to the Main Server will ensure smooth operations with the main data storage and processing unit and is critical for day to day operations of the Shire. The current software will no longer be supported by Microsoft, which means that the Shires risk if having IT issues or attacks are significantly increased if the server is not updated.

# Summary

To consider delegating to the CEO authority to approve Temporary Accommodation for a restricted period.

# **Background**

Changes have recently been made to the Caravan Parks and Camping Grounds Regulations 1997 to allow for local government to approved temporary accommodation for up to 12 months. This has been an initiative by State Government to allow people to camp on their own grounds while awaiting construction of a dwelling.

Local Government can approve camping for a period of not exceeding 24 months.

#### Comment

A State Government initiative has seen changes to the Caravan Parks and Camping Grounds Regulations 1997 to allow local government to approve camping on land for a period of up to 12 months. The relevant Regulation is Regulation 11A.

- 11A. Camping on private land with local government approval
  - (1) A person may apply in writing to a local government for approval to camp on land the person owns or has a legal right to occupy if the land is in the local government's district.
  - (2) The local government may approve the person camping on the land for a period specified in the approval not exceeding 24 consecutive months.
  - (3) The approval is subject to the following conditions
    - (a) that any caravan or camp in which the person is camping on the land is maintained in such a condition that it is not a hazard to safety or health;
    - (b) that the land is maintained in such a condition that it is suitable for camping, particularly in relation to
      - (i) safety and health; and
      - (ii) access to services:
    - (c) any other conditions specified by the local government in the approval.

- (4) The local government is taken to have refused the application if the local government does not give the approval within 63 days of the application.
- (5) The local government may revoke an approval given by the local government, by written notice to the holder of the approval, if the local government is satisfied that a condition of the approval has been breached.
- (6) Before revoking the approval, the local government must
  - (a) give written notice to the holder of the local government's intention to revoke the approval unless, within 35 days after the notice is given, the holder shows cause why the approval should not be revoked; and
  - (b) consider any written response to the notice received from the holder during that period.

[Regulation 11A inserted: SL 2024/162 r. 7.]

If the Local Government refuses to allow the temporary accommodation, the applicant can then apply to the Minister for approval under Regulation 11B

- 11B. Camping on private land with Ministerial approval
  - (1) This regulation applies if a local government does any of the following under regulation 11A (each a *relevant decision*)—
    - (a) refuses to give an approval a person has applied for;
    - (b) gives a person an approval for a period or subject to conditions specified by the local government in the approval;
    - (c) revokes an approval given to a person by the local government.
  - (2) The person may, within 35 days of the relevant decision, apply in writing to the Minister for approval to camp on the land the subject of the application or approval (as the case may be).
  - (3) The Minister may approve the person camping on the land for a period specified in the approval not exceeding 24 consecutive months.
  - (4) The approval is subject to the following conditions
    - (a) that any caravan or camp in which the person is camping on the land is maintained in such a condition that it is not a hazard to safety or health;
    - (b) that the land is maintained in such a condition that it is suitable for camping, particularly in relation to
      - (i) safety and health; and
      - (ii) access to services;
    - (c) any other conditions specified by the Minister in the approval.
  - (5) If a person makes an application in relation to a relevant decision referred to in sub regulation (1)(b), the relevant decision continues in force until the sooner of
    - (a) the day on which the Minister gives an approval on the application; or
    - (b) the day on which the relevant decision would otherwise cease to have effect.
  - (6) The Minister may revoke an approval given by the Minister, by written notice to the holder of the approval, if the Minister is satisfied that a condition of the approval has been breached.
  - (7) Before revoking the approval, the Minister must —

- (a) give written notice to the holder of the Minister's intention to revoke the approval unless, within 35 days after the notice is given, the holder shows cause why the approval should not be revoked; and
- (b) consider any written response to the notice received from the holder during that period.

The RoeROC EHO officers are currently developing a policy for all the RoeROC Shires to look at a process that can be adhered to by all the member Shires to ensure the policy is similar and does not create confusion for applicants. This policy is still being developed.

To reduce the number of applications going to Council, it is request to consider delegating the authority to the CEO to approve temporary accommodation for a period of 12 months (maximum as per Regulations is 24 months), to allow the person to start on their homes and make significant advances towards repairing a home of building a new home. If the applicant wants to extend the time, then the approval would be brought to Council where it can be justified form the amount of works done.

Currently the Shire has two land owners who are considering applying for temporary accommodation. One applicant is for Kondinin townsite to allow a person to restore an old home to be fit for habitation. The second applicant has submitted building plans for approval of a house in the Hyden townsite.
