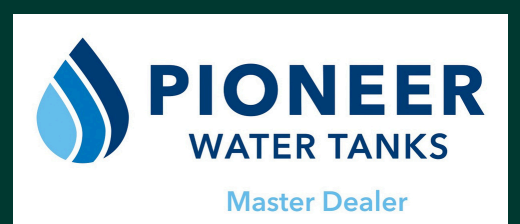

GENERAL INFORMATION

Persons burning without permits during the Restricted Burning Period or on days when a Very High or greater fire weather warning has been issued may be prosecuted.

RESPONSIBILITY

Section 28 of the Bush Fires Act provides that where a bush fire is burning during prohibited or restricted times, the occupier of the land shall forthwith, whether he or she has lit or caused such fire to be lit or not, take all possible steps to extinguish the fire.

Where owners or occupiers fail to extinguish the fire a Bush Fire Control Officer may take all proper measures to extinguish such fire and the expenses of that action are recoverable from owners and occupiers.

PENALTIES

Penalties apply for failure to comply with these regulations.

FIRE & HARVEST BAN SMS LIST

Once included in the Shire of Kondinin's Fire and Harvest Ban SMS list you will receive messages not limited to Harvest and Vehicle Bans, Fires/Emergencies, Standpipes and Farming.

SMS responses to this service are infrequently monitored so please contact the Shire Office directly if you would like clarification on anything you receive.

HARVEST AND VEHICLE MOVEMENT BAN (HVMB)

A HVMB is imposed by local government and prohibits the use of engines, vehicles, plant or machinery to avoid the start or spread of a bushfire.

This specifically applies to harvesting and moving vehicles in paddocks except vehicles carrying water for stock.

If a HVMB is declared it is notified via SMS, the Harvest Ban Hotline or ABC Radio.

TOTAL FIRE BAN (TFB)

A TFB is imposed, on a regional basis, on days when fires are most likely to threaten lives and property.

When a TFB is declared by DFES it is published on the Emergency WA & DFES Websites and broadcast by the ABC.

Burning is not permitted during the restricted burning period on Public Holidays, advertised Sundays or during Easter when Easter falls within the restricted burning period.

GENERAL PROVISIONS

Harvesting is not permitted on Christmas Day and New Years Day. A firefighting unit containing at least 500 litres of water must be in the same paddock as harvesting operations being conducted.

ASSISTING DURING A FIRE

People fighting fires are requested to report to the Fire Control Officer (FCO) upon arrival at the fire grounds. All fire fighters are requested to use Ch11 on radios at fires.

FIRE BREAKS

You are required on or before 31 October each year, to plough, scarify, cultivate, spray or otherwise clear and maintain free of all inflammable material until 30 April the next year, firebreaks on the land owned or occupied by you pursuant to the powers contained in section 33 of the Bush Fires Act 1954.

RURAL LAND

Firebreaks not less than 3 metres wide as follows:

i) Immediately inside all external boundaries of the land or rural holding and if any portion of the land or rural holding adjoins a public road or railway line a firebreak must also be constructed along that boundary.

ii) Immediately surrounding all buildings, haystacks and fuel ramps situated on the land. Please contact the Shire for the requirements of setting fire to prepared bush.

TOWNSITE LAND

All town site lots 2.012ha (5 acres) or less shall be clear of all inflammable materials and grass must be mown to a height of no greater than 15cm.

All town site lots or a combination of lots that comprise of one holding and greater than 2.012 ha (5 acres) require fire breaks of 1.25m wide on all boundaries and immediately surrounding all buildings.

If permission is not granted by Council or a duly authorised officer you shall comply with this Notice.

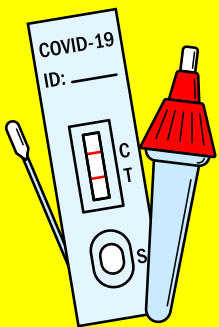

CEO COMMENTS

Spring is finally here and the warmer weather has arrived. Please be aware that snakes are also starting to come out as well.

Council Meeting

- For the September Ordinary Council Meeting, the following was discussed:
- An amendment was made to the Sports and Recreation Facilities Plan for the changing of the Hyden Tennis rooms roof to a new building.
- Council supported the concept plans for the new Tennis Club building and the seeking of funding for the facility.
- Council supported an application for funding through the State Government Community Water Supply for tanks and pipelines for Kondinin and Karlgarin.
- Council supported the lease of additional space at the JW West Building for a museum for Kondinin.
- Council Noted the building reports from the Housing and Building Committee and the recommendation for construction of a house in Kondinin was supported.
- Council approved the waiving of Development Fees for the KCRC housing construction for Nurses Accommodation.
- The 2024-2025 Budget was adopted by Council.

- Council received submission for the Discovery Centre Business Plan and requested the Working Group to provide a Questions and Answers response. A funding application was approved for Growing Regions providing information can be supported. This will go back to Council before the application is made.
- Council approved the Christmas Office Hours for the Administration Centres.
- Council endorsed the Bush Fire Brigade Fire Control Officers for 2024-25.
- Council approved the Prohibited Burning Period to be from 1st November to 14th February 2025.
- Council will request from the Department of Commerce for extended trading hours for the Harvest/Christmas season.
- Council adopted the Tourism Master Plan for the Shire of Kondinin.
- Council supported in principle the transfer of the Hyden CWA building to the Shire and a return lease.

FIRE BREAKS REQUIRED

A reminder that Fire Breaks are required to be installed for properties in the Shire by the end of October.

If you have created a fire break by chemical means, please ensure the grass does not remain to allow fire to spread. Grass remaining in fire breaks may void insurance policies and cause fire to spread unintentionally.

Burning Permits are required.

For burning any grass or materials, Burning Permits are now required

Please check with your Fire Control Officers for permits and ensure no fires are started when adverse weather conditions apply.

3G Closure: Check if your Telstra GO has the latest software update and is configured to boost 4G signal

Many Telstra GO Repeaters operate on both 3G and 4G and will not be impacted when 3G closes from 28 October 2024. However, in some instances they may have been configured to only operate on 3G and hasn't been updated with the latest software. We encourage you to check your Telstra GO Repeater settings using a smartphone with the Cel-Fi WAVE app installed to see if its correctly configured to boost 4G signals and has the latest software update.

To ensure you are getting the best possible 4G experience when 3G closes on 28 October 2024, we've created a handy factsheet with instructions to update your Telstra Go repeater with the latest software, check setting on your device so it is boosting 4G coverage and to also check if your current antenna is compatible with the 4G network. 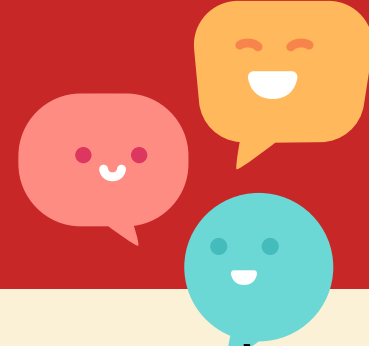
