Council Meetings

For the March Ordinary Council Meeting, the following was discussed:

- The extension of the Kondinin Wind Farm Development Application was considered with some amendments.
- The Shire is looking at changes to the Reserve in Hyden to allow for expansion of Waveline Tyres.
- Rental for a Shire property was considered for increase and renewal.
- An Agreement was authorised for the shared facilities of the Hyden oval with the Hyden Primary School.
- Advertising of the Draft Local Planning Policy No.5 - Heritage List was approved.
- Advertising of the proposed Shire Heritage List was approved.
- A small amount of interest incorrectly raised was written off.
- An Update on the Discovery Centre was provided.

- The Compliance Audit Return for 2024 was approved for submission.
- Information from the Annual Electors Meeting held in Kondinin on 12th February was presented.
- The Shire will be using the WA Electoral Commission to conduct the 2025 Local Government Elections in October this year.
- Council approved the transfer of the Hyden CWA Hall to the Shire and lease back to the local Hyden CWA Group.
- Council has approved applying for funds for the East Hyden Bush Fire Brigade to have a permanent unit
- The use of the Common Seal on a land transfer document was approved.
- Council is working with RoeROC to provide Key Worker Housing projects to allow the Shires to develop housing in our towns.
- The Shire will be supporting the Early Years' Learning group with items in Kondinin.

HEALTHWAY – HEALTHY COMMUNITIES PROGRAM



This program aims to fund a range of health promotion activities and campaigns to promote and encourage healthy lifestyles for all Western Australians.

The objectives of the program are to:

- Fund activities related to the promotion of good health in general and aligned with our strategic priorities and population groups.

Creamy chicken and mushroom fettuccine



Total Time: 30 Minutes



Serves:4



Ingredients

- 450g fettuccine
- 1 tbsp olive oil
- 650g chicken tenderloins, tendons removed
- 125g rindless bacon, diced
- 1 brown onion, diced
- 300g small cup mushrooms, sliced
- 420g can Heinz Condensed Cream of Chicken Soup
- 1/2 cup light thickened cream
- 1 tbsp worcestershire sauce
- 1/2 cup fresh flat-leaf parsley, roughly chopped

Method

Step 1
Cook pasta in a large saucepan of boiling, salted water, following packet directions, until tender. Drain pasta, reserving 2 tablespoons cooking water. Return pasta and water to the saucepan.

Step 2
Heat 2 teaspoons of oil in a large, non-stick frying pan over medium-high heat. Add half the chicken. Cook for 4 minutes on each side or until golden. Remove to a plate. Cover to keep warm. Repeat with remaining chicken, adding more oil if necessary. Cut chicken tenderloins diagonally into 3 pieces.

Step 3
Add bacon to frying pan. Cook for 2 minutes. Add onion and mushrooms. Cook, stirring occasionally, for 4 to 5 minutes or until mushrooms are golden. Add soup, cream and worcestershire sauce. Stir until well combined. Add mushroom mixture, chicken and parsley to pasta. Toss to combine. Season with cracked black pepper. Serve.
